## HOW TO HOLD TRANSMATIONAL RESPONSIBLE FOR HUMAN RIGHTS VIOLATIONS

The work of the **UN OPEN ENDED INTER-GOVERNMENTAL WORKING GROUP (OEIGWG)** developing a legally binding international instrument on Transnational Corporations and other business enterprises is now in its second year. This OEIGWG was mandated in June 2014 (AHRC/29/6) and its work has opened a new historic chapter in putting the challenge of regulation of TNCs back on the international agenda. Furthermore it underscores the search for effective alternatives on the trade, investment and access to justice.

This Public Hearing at the European Parliament on May 30th is an important step in making the work of the OEIGWG widely known among Parliamentarians and in developing a momentum of support and constructive public debate. This is particularly important in the European context, where the EU member states have until now acted as a bloc within the UNHRC to oppose the initiative.

#### **OBJECTIVES OF THE PUBLIC HEARING**

The overall objective is to broaden and strengthen the participation and engagement of members of the European Parliament (EP) and National Parliaments to support the growing momentum on this initiative and heighten Parliamentary profile in the process.

#### SPECIFIC OBJECTIVES INCLUDE

To contribute to enriching the debate on the arguments for the Binding Treaty — involving human rights and international law experts, parliamentarians and social movement leaders.

To mobilise Parliamentary expertise in developing the proposals that will feed into and finally shape the provisions of the Treaty.

To identify moments in the Political Calendar which can be conducive to advancing the work of the OEIGWG.
